APPEAL by Philip Jones of 58 Springfield Avenue, Templeogue, Dublin, against the decision made on the 28th day of February, 1974, by the Hight Honourable the Lord Fayor, Aldermen and Burgesses of Dublin deciding to grant subject to conditions a permission to Ers. Killiam Langan, 59 Springfield Avenue, for the erection of a 2 storey dwelling bouse on a site at 59 Springfield Avenue.

Templeogue:

DECISION: Pursuent to subsection (5) of section 26 of the Local Government (Planning and Development) Act, 1963, and after consideration of the report of the person who conducted an oral hearing of the said appeal, permission is hereby refused for the erection of the said dwelling house for the reasons set out in the Schedule hereto.

SCORNING

- 1. The development would be seriously injurious to the amenities of the area because the proposed house, which would be sandwiched between two pairs of semi-detached houses, would be visually incongruous, would disrupt the elevation presented by the existing houses onto Springfield Avenue and would create an effect of overcrowding on what is a relatively narrow site.
- 2. The garage/parking at the rear of the proposed new house would be unsatisfactory as it would be approached from Springfield Road and would not be convenient to the front entrance to the house.
