In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/3114/74 dated 25th September, 1974 decide to refuse:

for Proposed free standing sign in car park at Shopping Centre,

for the following reasons:

- 1. The proposed development is inconsistent with the proper planning and development of the area as the sign due to its location and size would be visually obtrusive and detrimental to residential amenity in the area.

The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and should be addressed to the Secretary, (Planning Appeals Section), Department of Local Government, Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
