APPEAL by Daniel Coyne of 23 Sarsfield Park, Lucan, County Dublin, against the decision made on the 27th day of June, 1974 by the Council of the County of Dublin deciding to refuse outline permission for the construction of a house on a site at Kellystown, County Dublin:

DECISION: Pursuant to subsection (5) of section 23 of the Local Government (Planning and Development) Act, 1963, and after consideration of the reports of the persons who conducted an oral hearing of the said appeal, outline permission is hereby refused for the construction of the said house for the reason set out in the Schedule hereto.

SCHEDULE

The major portion of the site is expected to be required for future road improvement works in the area, and the erection of a new dwelling on the site would prejudice the carrying out of these works.
