- 1. The site is located in an area zoned to provide for the further development of agriculture in the Development Plan. The development proposed would be in conflict with this objective and would not be in accordance with the proper planning and development of the area.
- 2. The site proposed forms a small part of the lands which were the subject of a special permission for a bungalow and out house by Order Nos. TP/983/55 dated 1/12/55, decisions to grant permission for the erection of a bungalow by order Nos. P"236/72 dated 21/1/72, P/1433/78 dated 12/6/72 and P/155/73 dated 18th January, 1973, and thus be at variance with these previous applications and permissions for the erection of a single bungalow on the entire site, and the erection of an additional dwellinghouse would not be in accordance with the proper planning and development of the area.
- 3. Public piped sewerage facilities are not available to serve the proposed development.
- 4. The proposed development would be premature by reason of the said existing deficiency in the provision of sewerage facilities and the period within which such deficiency may reasonably be expected to be made good.
