PATENT PLANNING PERMIT
LOCAL GOVERNMENT (PLANNING AND DEVELOPMENT) ACT, 1957

APPEALS by Cornelius Lonergan, 32 Hillside Drive, Rathfarnham, Dublin and Kenneth Feijor, 23 Hillside Drive, Rathfarnham, Dublin, against the decision made on the 13th day of December, 1973 by the Right Honourable the Lord Mayor, Aldermen and Burgesses of Dublin deciding to grant subject to conditions a permission to Terence McCovern, 30 Hillside Drive, Rathfarnham for the erection of a kitchen, dining room and bedroom extension at Number 30 Hillside Drive, Rathfarnham, Dublin, in accordance with plans and particulars lodged with the Corporation:

DECISION: Pursuant to subsections (5) and (9) of section 26 of the Local Government (Planning and Development) Act, 1957, and after consideration of the report of the person who conducted an oral hearing of the said appeal, it is hereby decided to grant permission for the erection of the said extension, subject to the conditions specified in column 1 of the Schedule hereto, the reasons for the imposition of the said conditions being as set out in column 2 of the said Schedule and the said permission is hereby granted subject to the said conditions.

SCHEDULE

Column 1 - Conditions

1. The proposed window at first floor level in the side wall of the extension shall be relocated in the rear wall of the said extension.
2. The dwellinghouse and extension shall be used as one single dwelling unit.
3. The overall height of the extension at first floor level shall be reduced by not less than twelve inches.

Column 2 - Reasons for Conditions

1. To protect the amenity of the adjoining dwellinghouse.
2. To ensure that the development will not be out of character with existing residential development in the area which consists predominantly of houses designed for single family occupation.
3. To safeguard the residential amenity of the adjoining dwellinghouses.
