In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order p/1372/69 dated 15th August, '69 make a decision pursuant to Section 26(1) of the Act. refusing outline permission for:

Proposed Warehouse and Assembly Plant at Garrynisk, Belgard Road, Tallaght.

for the following reasons:-

1. Public piped sewerage facilities are not available to serve the proposals.
2. The proposed development would be premature by reason of the said existing deficiency in the provision of sewerage facilities and the period within which such deficiency may reasonably be expected to be made good.
3. The eastern portion of the site is likely to be seriously affected by the Council's future major road proposals in this area.

The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and the nature of the applicant's interest in the property affected and should be addressed to the Secretary, Department of Local Government, (Planning Appeals Section), Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for outline permission as if it had been made to him in the first instance.
