subject to the following conditions:-

- (1) That the development be carried out and completed strictly in accordance with the plans and specification lodged with the application, save as is in the conditions hereunder otherwise required.
- (2) That the water supply and drainage arrangements shall be in accordance with the requirements of the County Council and particularly the design and location of the proposed septic tank and any necessary trial-holes must be approved by the Sanitary Authority, 6, Parnell Square, before any construction work takes place.
- (3) That Building Bye-Laws Approval shall be obtained and any conditions of such approval shall be observed in the development.
