In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/582/69 dated 25th April, 1969.  
~~PERMISSION~~ decision pursuant to Section 26(1) of the Act to grant an approval for: Proposed two houses at Park Road, Daerpark, Castleknock.

**Conditions:**

- (1) That the development be carried out and completed strictly in accordance with the plans and specification lodged with the application, save as is in the conditions hereunder required.
- (2) That a financial contribution in the sum of £260. be paid by the proposers to the Dublin Co. Council towards the cost of provision of public services in the area of the proposed development; and which facilitate this development, this contribution to be paid before the commencement of development on the site.
- (3) That the applicant obtain permission from the Board of Works for the proposed method of discharging surface water and the documentary evidence of this permission be lodged with the County Council before any work takes place.
- (4) That Building Bye Laws approval shall be obtained

**Reasons for conditions:**

- (1) To ensure that the development shall be in accordance with the permission and effective control maintained.
- (2) In the interests of the proper planning and development of the area.

The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and the nature of the appellant's interest in the property affected and should be addressed to the Secretary, Department of Local Government, Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for approval as if it had been made to him in the first instance.
