APPLICANT

In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/365/69 dated 20th March, 1969 make a decision pursuant to Section 26(1) of the Act to grant a permission for:
Proposed dwellinghouse at Templeogue Road, Templeogue.

Floor area: 2,100 sq.ft.

subject to the following conditions:-

Reason for conditions:

- (1) That the development be carried out and completed in strict conformity with the plans and specification lodged with the application.
- (2) That the necessary land be reserved for the improvement of the main Templeogue Road, as indicated on map No. C.P. 487, already furnished.
- (3) That the house be set back a minimum distance of 35-ft. from the proposed road improvement line.
- (4) That the external finishes ~~including~~ including the roof, harmonise in colour and texture with the adjoining development.
- (5) That Building Bye-Laws Approval shall be obtained and any conditions of such approval

- (1) To ensure that the development shall be in accordance with the permission and effective control maintained.
- (2) In the interests of the proper planning and development of the area.
- (3) In the interests of the proper planning and development of the area.
- (4) In the interests of visual amenity.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.

NOTE: An appeal against the decision may be made to the Minister by the applicant within one month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and the nature of the appellant's interest in the property affected and should be addressed to the Secretary, Department of Local Government, (Planning Appeals Section), Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.

Approval of the Council under Building Bye Laws must be obtained and the terms of the approval must be complied with in the carrying out of the work before any development which may be permitted is commenced.
