- (1) That the development be carried out and completed in strict conformity with the plan and specifications laid down in the specifications. It is further stated that the development shall be in accordance with the provisions and conditions set forth in the specifications.
- (2) That the proposed construction be completed within the specified time by means of a contract, plan, or otherwise, including the proposed technical details which shall be binding upon the contractor of work and be subject to the provisions of the specifications and from the contract.
- (3) That the contractor shall not be held for any purpose other than a purpose incidental to the execution of the construction in such, and at any time as a separate building. (In the interests of economy).
- (4) That building construction shall be absolute and any construction of such material shall be covered in the construction. (In accordance with the specifications and drawings, 1954 - 1956).
