With reference to your planning application, received here on 24.07.92 in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts 1963 - 1991, the following additional information must be submitted in quadruplicate:-

01 The proposed development is unacceptable to the Principal Environmental Health Officer for the following reasons: (i) The soil does not appear suitable for the treatment and disposal of septic effluent. (ii) Full design details and specifications of the biocycle have not been submitted. (111) Results of any tests undertaken by biocycle or the applicant have not been submitted. (iv) Distance between the biocycle unit and well water supply insufficient. (v) Bacteriological and chemical analysis of water have to be submitted.
