Shopping Centre at Bullcroft Avenue (Old Rathfriland Golf Course)

Floor Area - 50,000 sq. ft.

- (1) That the application be carried out and completed in strict conformity with the plans and specifications lodged with the application, and as in and to the conditions hereinafter otherwise required.
- (2) That details of the internal arrangements in the buildings, including access, areas, effective retail sales areas and other accessories shall be submitted to and approved by the County Council before any construction work takes place; the red areas shall be related to the proposed car parking facilities.
- (3) The requirements of the Council's Town Officer, if any, shall be a condition in the development.
- (4) The proposed access opposite Brian Road shall be relocated west of the junction of Lifford Road, in accordance with the Council's Town Officer's consent with the Council's Town Officer in this regard.
- (5) The proposed landscaping at the junction of Lifford Road, in accordance with the Council's Town Officer's consent, shall be a condition in the development.
- (6) A minimum circulation width of 1.5m shall be provided at the rear of the development.

(7) A satisfactory landscaping scheme shall be submitted to and approved by the Council for the purpose of providing to rear of the proposed building.

(8) That Building Bye-Laws approved shall be obtained and any conditions of such approval shall be observed in the development.

Where the applicant is a person to consult with the Planning Authority and the Authority is satisfied that the applicant is a person to consult with the Planning Authority referred to in Section 5(2) above.
