Condition

Reason for condition
In order to comply with the provisions of the Local Government (Planning and Development) Act, 1963.
In the interests of the proper planning and development of the area.

- (1) That no constructional work be put in hand until detailed drawings have been submitted to and approved by the Council under the Local Government (Planning and Development) Act, 1963.
- (2) That the land required for the future Ring Road to the north of the site be reserved as such.
- (3) That cognisance should be taken in the setting out of the Ring Road and the over-all development of the Council's proposal to lay a main trunk sewer through the site. For this purpose a wayleave will be required by the Council which should be provided for by the developer. (Particulars of the location and other details of this trunk sewer can be obtained from

- (4) In the interests of the proper planning and development of the area.
- (5) In the interests of the proper planning and development of the area. (NPC)

- (3) the Sanitary Service Section of the County Engineer's Department.
- (4) That the land on the east side of the site which was reserved as public open space in the original permission for the development of the estate, be reserved as such.
- (5) That the main entrance to the site be located, as indicated on the plan, on the west side of the site.
