Proposed Dwellings at 11 Ave.

1. That the development be carried out and completed in strict conformity with the plans and a subdivision lodged with the application. (To ensure that the development shall be in accordance with the provision and effective control maintained.)
2. That the proposed dwellings be not less than 60 ft. from the existing road boundary. (In the interests of visual amenity).
3. That adequate landscaping be provided adjoining the proposed dwellings. (In order to protect and improve the existing conditions of the area).
4. That the proposed roof finish line with the surroundings in colour and texture. (In the interests of visual amenity).
5. That Building By-Laws approved shall be obtained and any conditions of such approval shall be observed in the development. (In order to comply with statutory provisions note, 1878-1944).
