Dear Sir,

With reference to your planning application, received here on 24th December, 1986, in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts, 1963-1983, the following additional information must be submitted in quadruplicate:-

1. Further information is required which will provide for:-

(a) That the works proposed for the carport conversion are not considered exempt in relation to the overall construction works proposed at ground and first floor level. A revised public advertisement is required which should clearly incorporate all of the ground floor and first floor works.

(b) It appears that the proposed work may interfere with the amenities of adjoining residential premises. Applicant is asked to indicate if he has the agreement of the adjoining owners to his proposals.
