With reference to your planning application, received here on 26th November, 1986, in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts, 1963-1983, the following additional information must be submitted in quadruplicate:-

1. The applicant is requested to clarify its intentions in respect of:-
 - a. the landscaping of grassed areas/residual parts of the site to the west and south, outside the new boundary wall and contiguous with adjoining public open space (as per conditions Nos. 4 and 5 of Reg. Ref. 85A-821, the original permission for the construction of this boundary wall). In this regard, the applicant shall consult directly with the Parks Department prior to submission of additional information in the Planning Department;
 - b. the external finishes and capping of the wall as per Condition No. 3 of Reg. Ref. 85A-821.
