With reference to your planning application, received here on 1/10/'86, in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts, 1963-1983, the following additional information must be submitted in quadruplicate:-

1. The applicant is requested to submit:-
 - a) elevations to laneway and car park of the building proposed to be retained.
 - b) proposals to accommodate surface water drainage including the existing car parking area. No storm water shall be discharged to the foul sewer;
 - c) proposals for on site landscaping, including the existing car park with particular attention to the road frontage.
2. The applicant is requested to indicate proposal to minimise possible noise/disturbance, arising from the proposed use of the premises as a 'disco bar'.
3. Applicant to confirm that premises will not be used for dancing.
