Dear Sir,

With reference to your planning application, received here on 23/7/'86, in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts, 1963-1983, the following additional information must be submitted in quadruplicate:-

1. Due to the lack of dilution in the receiving water of the Newcastle Treatment Plant the County Council has found it necessary to refuse permission for all development in this area which requires a connection to the Newcastle Treatment Plant. The only exception to this policy would be where the Council were satisfied that extreme hardship would result in not allowing such a connection to be made for an individual house. The applicant is asked to identify any circumstances which might exist in relation to this matter.

2. Details of front and side boundary treatment are required together with details of piers. In this regard, gate piers should be setback 1.2 metres with wing walls splayed at 45°.
