Dear Sir,

With reference to your planning application, received here on 2/7/'86, in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts, 1963-1983, the following additional information must be submitted in quadruplicate:-

1. The applicant to submit an accurate and complete site map of his family land holding in the area. It is recommended that an ordnance survey extract to a scale of 1:2500 be submitted for this purpose.
2. The applicant to submit details of his specific need for a dwelling house in this rural area and refer to any connection he may have with the area.
3. The applicant is to specify the relationship of this 1-acre site with the adjoining land holding of 16 acres and whether his family are prepared to sterilize the balance of this site from further residential or commercial development.
4. The applicants specific proposals for adequate and necessary vision splays at the junction of Carrigeen Lane and Killeel Road. Consultation and agreement with the Roads Engineer is required.
5. No evidence of site suitability for septic tank drainage has been submitted. Applicant to submit these details:-
