<p>1. The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.</p> <p>2. The existing hedge on both sides of entrance to be removed where it is affected by vision splays. A new 1 metre high post and rail wooden fence stained dark brown to be erected along vision lines so that they are not obstructed. Hawthorn slips at 0.3 metre intervals to be planted immediately inside the wooden fence. Outer piers and wing walls to be set back to vision lines. Area between existing carriageway and new fence to be levelled and seeded with grass and maintained.</p> <p>3. Car parking area to be provided prior to the utilisation of playing fields.</p>	<p>1. To ensure that the development shall be in accordance with the permission and that effective control be maintained.</p> <p>2. In the interests of traffic safety and amenity.</p> <p>3.
