In pursuance of its functions under the above-mentioned Acts, the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order, P/ 1557/86, dated 3/5/86 decided to refuse:

For Proposed new vehicular access onto Knocklyon Road, Templeogue.

for the following reasons:

1. The proposed development which would lead to the generation of additional traffic turning movements on the heavily trafficked district distributor road between two existing junctions would endanger public safety by reason of a traffic hazard.
2. The proposed entrance onto the newly improved Knocklyon Road which is intended to be a main link road, free of frontal development, to the Western Parkway/Southern Cross Route would reduce the capacity of the link road and would not be in accordance with the proper planning and development of the area.

NOTE: (1) An appeal against the decision may be made to An Bord Pleanala. The applicant may appeal within one month from the date of receipt by him of this notification. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of appeal and should be addressed to *An Bord Pleanala, Irish Life Centre, Lower Abbey Street, Dublin 1*. An appeal lodged by an applicant or his agent with An Bord Pleanala will be invalid unless accompanied by a fee of £36. (Thirty-six pounds). (2) A party to an appeal making a request to An Bord Pleanala for an oral hearing of an appeal must, in addition to (1) above, pay to An Bord Pleanala a fee of £36. (Thirty-six pounds). (3) A person who is not a party to an appeal must pay a fee of £10 (Ten pounds) to An Bord Pleanala in relation to an appeal. When an appeal has been duly made and has not been withdrawn, An Bord Pleanala will determine the application for permission as if it had been made to them in the first instance.
