With reference to your planning application received here on 11th June, 1982, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts, 1963 & 1976 the following additional information must be submitted in quadruplicate:-

1. Further information is required which should provide for:-
 - a. Clarification of the long term access arrangements to the site together with specific proposals in relation to the existing access so that a safe vehicular movement facility can be provided to the public road.
 - b. An indication of the existing and anticipated vehicular movements to and from the site and times during which these occur.
 - c. Clarification of the uses for the existing storage and other ancillary structures on the site.
 - d. The applicant's specific proposals for boundary and site protection measures so as to ensure that the amenities of adjoining residential properties are preserved.
