1. The applicant should indicate if he is in a position to  
satisfy the requirements of the Sanitary Services Engineer  
in relation to foul sewer facilities. The proposed block,  
on the submitted plans, is indicated too close to a County  
Council trunk sewer which traverses the site. The applicant  
should submit plans indicating the proposed block in relation  
to the sewer. No building is to be located within 5m. of the  
centre line of the sewer.
