- (a) No signs, save those exempted under the Local Government (Planning and Development) Regulations, 1977, as amended, shall be erected externally within the site, without a prior grant of planning permission by the planning authority or by An Bord Pleanála on appeal.
- (b) No changes to the street facade of the building shall take place without a prior grant of planning permission by the planning authority or by An Bord Pleanála on appeal.

Reason: In the interests of the visual amenities of the area.

2. The use hereby permitted shall be the servicing, repair and temporary storage of mobile cranes and ancillary plant which are in the applicant's ownership. Reason: To control the intensity of use and the volume of traffic movements associated with the development in the interest of traffic safety.
