APPEAL by Trackline Limited, of 10, Ballymount Road Upper, Tallaght, against the decision made on the 23rd day of January, 1986, by the Council of the County of Dublin, to refuse permission for the retention of a lock-up workshop at 10 Ballymount Road Upper, Tallaght, in accordance with plans and particulars lodged with the said Council:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1983, it is hereby decided, for the reason set out in the First Schedule hereto, to grant permission for the said retention in accordance with the said plans and particulars, subject to the conditions specified in the Second Schedule hereto, the reasons for the imposition of the said conditions being as set out in the said Second Schedule and the said permission is hereby <u>granted</u> subject to the said conditions.

## FIRST SCHEDULE

Subject to the conditions set out in the Second Schedule hereto, it is considered that the retention of this development, which is small in scale and likely to generate only a low volume of traffic movements, would not be contrary to the proper planning and development of the area.

#### SECOND SCHEDULE

 Access from the site directly onto Ballymount Road Upper shall be temporary only and shall be replaced by access via the industrial estate road at the rear of the site as soon as this latter access route becomes available.

Reason: To control the number of single access points onto Ballymount Road Upper, in the interest of the orderly development of the area.
