

APPEAL by Elmcastle Residents, care of Patrick and Bridget Kennedy of 18, Elmcastle Court, Kilnamanagh, County Dublin, against the decision made on the 24th day of October, 1985, by the Council of the County of Dublin, to grant subject to conditions an outline permission to Kilnamanagh Residents Association, care of Denis Macken, of 1, Redwood Close, Kilnamanagh Estate, County Dublin for a community centre at Treepark Road, Kilnamanagh, County Dublin, in accordance with plans and particulars lodged with the said Council:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1983, it is hereby decided, for the reasons set out in the First Schedule hereto, to grant outline permission for the said community centre in accordance with the said plans and particulars, subject to the conditions specified in the Second Schedule hereto, the reasons for the imposition of the said conditions being as set out in the said Second Schedule and the said outline permission is hereby granted subject to the said conditions.

FIRST SCHEDULE

It is considered that the proposed development, carried out in accordance with the conditions set out in the Second Schedule would be consistent with the proper planning and development of the area, and would not be injurious to the residential amenities of the area.

SECOND SCHEDULE

The detailed plans and particulars to be submitted to the planning authority for approval shall have regard to such matters as the design and location of the vehicular access to the site, on site parking area, boundary treatment of the site, landscaping of the site, the design of water supply, drainage and surface water details.

Reason: To ensure a proper standard of development.

SECOND SCHEDULE (CONTD.)


 Before development commences, the reservation for the Greenhills Road realignment shall be set out on the site in consultation with the planning authority.

Reason: In the interests of the proper planning and development of the area.


