APPEAL by Thomas Kavanagh, of Piperstown Lane, Piperstown, County Dublin, against the decision made on the 11th day of April, 1986, by the Council of the County of Dublin, to refuse permission for development described in the public notice as alterations to existing cottage and retention of caravan on site, for the duration of the works at Piperstown Lane, Piperstown, County Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1983, permission is hereby refused for the development so described for the reasons set out in the Schedule hereto.

#### SCHEDULE

- 1. The site is located in the Dublin Mountains in an area zoned in the Dublin County Development Plan, 1983, to protect and improve high amenity areas. It is the Council's policy that any development in this area not directly related to its amenity potential or use for agriculture, mountain or hill farming should be prohibited. This policy is considered reasonable and the proposed development would be in conflict with it.
- The former residential use of the structure has been abandoned for a considerable period and the use of the structure as a dwelling would detract from the existing residential amenity of the adjacent dwelling immediately to the west of the site.
