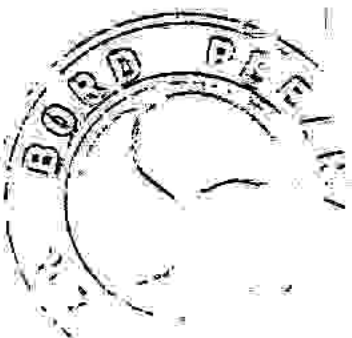

NOTE: (1) An appeal against the decision may be made to An Bord Pleanála. The applicant may appeal within one month from the date of receipt by him of this notification. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of appeal and should be addressed to An Bord Pleanála, Irish Life Centre, Lower Abbey Street, Dublin 1. An appeal lodged by an applicant or his agent with An Bord Pleanála will be invalid unless accompanied by a fee of Thirty-six pounds. (2) A party to an appeal making a request to An Bord Pleanála for an oral hearing of an appeal must, in addition to the fee of Thirty-six pounds, pay to An Bord Pleanála a fee of £36. (Thirty-six pounds). (3) A person who is not a party to an appeal must pay a fee of £36. (Thirty-six pounds). When an appeal has been duly made and has not been withdrawn, the applicant for permission as if it had been made to them in the first instance.
