1. Further information is required which would provide for:-
 - a. Evidence of soil suitability for septic tank effluent treatment and disposal including any necessary trial holes;
 - b. The location of septic tank, percolation areas and well (if any) serving the adjoining existing house should be indicated on the site layout map;
 - c. Details of proposed water supply;
 - d. Details of septic tank and design are required as well as evidence that the size is adequate for the use proposed;
 - e) Details of adequate and safe vehicular access to the existing road network;
 - f. Location of the related golf course.
