APPEAL by Glenfield Residents Association, care of 12, Glenfield Grove, Clondalkin, Dublin, against the decision made on the 29th day of April, 1985, by the Council of the County of Dublin to grant subject to conditions a permission to Ignatius Keane of 17, Wheatfields Close, Clondalkin, Dublin, for the retention of a doctor's surgery at 17, Glenfield Avenue, Clondalkin, Dublin, in accordance with plans and particulars lodged with the said Council:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1983, it is hereby decided, for the reason set out in the First Schedule hereto, to grant permission for the retention of the said doctor's surgery, in accordance with the said plans and perticulars, subject to the conditions specified in the Second Schedule hereto, the reasons for the imposition of the said conditions being as set out in the said Second Schedule and the said permission is hereby granted subject to the said conditions.

FIRST SCHEDULE

It is considered that the retention of the surgery for a limited period would, subject to compliance with the conditions set out in the Second Schedule hereto, be consistent with the proper planning and development of the area.

SECOND SCHEDULE

 The use of the ground floor of the dwelling as a doctor's surgery shall cease on 31 August, 1987, unless prior permission for its retention after that date shall have been granted by the planning authority or on appeal by An Bord Pleanála.

Reason: To allow the applicant time to find suitable alternative premises within the Quarryvale catchment area. The continuing use of the house in Glenfield Estate is not acceptable in principle.

 The entire house shall revert to use as a single dwelling unit when the approved use of the ground floor as a surgery ceases.

Reason: In the interests of existing residential amenity.
