provisions**

**Provision for existing factory at Bullpenny Road**

**Floor area - 7,000 sq.ft.**

**Conditions**

- (1) That the development be carried out and completed in strict conformity with the plans and specifications lodged with the application.
- (2) That the requirements of the Council's Plans Officer be adhered to in the development.
- (3) That the drainage arrangements be in accordance with the requirements of the County Council.
- (4) That adequate ear parking and loading/unloading facilities be provided.
- (5) That Building Bye-Laws approved shall be observed and any conditions of such approval shall be observed in the development.

**Provision for Council**

- (1) To ensure that the development shall be in accordance with the general and effective control maintained.
- (2) In the interests of public safety and avoidance of traffic hazard.
- (3) In order to comply with Building Bye-Laws 1975-1976.
- (4) To provide for the proper planning and development of the area.
- (5) In order to comply with Building Bye-Laws 1975-1976.
