In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/23/68 dated 8th January 1968 decision pursuant to Section 26(1) of the Act to grant a permission for:

10KV Substation at Marian Road, Butterfield Avenue, Rathfarnham

Floor area - 400 sq.ft

subject to the following conditions:-

- (I) That the development be carried out strictly in accordance with the plans and specification lodged with the application. (To ensure that the development shall be in accordance with the permission and effective control maintained).
- (2) That the external finish harmonise in colour and texture with the existing development. (This requirement refers to visual amenity).
- (3) That Building Bys-Laws Approval shall be obtained and any conditions of such approval shall be observed in the development. (In order to comply with Sanitary Services Acts, 1878 - 1964).

If there is no appeal to the Minister for Local Government against this ision, permission will be granted by the Council on the expiration of period for the taking of such appeal. If every appeal made in ordance with the Act has been withdrawn, the Council will grant the mission as soon as may be after the withdrawol.

When an appeal has been duly made and has not been withdrawn the Minister For Local Government will determine the application for permission as if it had been made to him in the first instance.
