10KV Transformer Substation at Wainsfort Park, Templeogue

Floor area - 240 sq.ft

subject to the following conditions:-

- (1) That the development shall be carried out strictly in accordance with the plans and specification lodged with the application.
(To ensure that the development shall be in accordance with the permission and effective control maintained).
- (2) That the external finish harmonise in colour and texture with existing buildings. (This requirement refers to visual amenity).
- (3) That Building Bye-Laws Approval shall be obtained and any conditions of such approval shall be observed in the development.
(In order to comply with the Sanitary Services Acts, 1878 - 1964).

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.
