In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/1336/67 dated 8th December 1967 make a decision pursuant to Section 26 (1) of the Act to grant an outline permission for:

Housing development at Commons Road, Newcastle

subject to the following conditions:-

(I) That no constructional work be put in hands until detailed drawings have been submitted to and approved under the Local Government (Planning and Development) Act, 1963 by the County Council.

(2) That the necessary land be reserved for the junction improvement of Commons Road with the Newcastle/Rathcoole Main Road at the west boundary of the site.

(3) That access to the land at the rear of the site be provided approximately at the centre of the site frontage.
