- (3) That the requirements of the Dublin County Council in respect of fire prevention be complied with in the construction of the building.
- (4) That the requirements of the Dublin Health Authority and the Dublin Sanitary Authority, respectively, be complied with in the development.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in dance with the Act has been withdrawn, the Council will grant the ssion as soon as may be after the withdrawal.
