In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/895/67 dated 13th September 1967 make a decision pursuant to Section 26(1) of the Act to grant a permission for:

Extensions to 76 Greentrees Road, Terenure

subject to the following conditions:-

- (1) That the development be carried out and completed in strict conformity with the plans and specification lodged with the application.
- (2) That Building Bye-Laws Approval shall be obtained and any conditions of such approval shall be observed in the development.
- (3) That the new window to light the landing should have a sill level not less than 5ft from the floor of the landing and that it be glazed with non-transparent glass

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.
