In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order 2/782/67 dated 25th Aug., 1967 make a decision pursuant to Section 26(1) of the Act to grant a permission for:

Factory Development at Gallenstown & Ballyfermot Upper.

subject to the following conditions:-

1. That the development be carried out and completed in strict conformity with the plans and specification lodged with the application.
2. That a financial contribution calculated in the manner set out below be paid by the applicants to the Dublin County Council towards the cost of future provision of public piped sewerage in the area of the proposed development and which facilitates the proposed development:- The contribution will be calculated at the rate of £300 per acre in respect of the area of the site which is the subject of this application.
3. That the drainage arrangements be in accordance with the requirements of the County Council.
4. That a satisfactory landscaping scheme be submitted to and approved by the County Council; the landscaping proposals to provide for both the new buildings and the car parking areas.
5. That Building Bye-Laws approval shall be obtained and any conditions of such approval shall be observed in the development.

there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.
