NOTIFICATION OF A DECISION ON AN APPLICATION FOR A PERMISSION

APPLICANT Messrs. Chadwicks Dublin, Ltd.

In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/339/67 dated 8th June, 1967 make a decision pursuant to Section 26(1) of the Act to grant a permission for:

Development of site for open-air storage of building materials at

Greenhills Road, Walkinstown.

Subject to the following conditions:-

1. That the proposed development be screened from view of adjoining roads and existing development by suitable quick growing evergreen trees of approved variety planted along the site boundaries.
2. That Planning Permission be obtained for any future access to the site from Greenhills Road, before same is created.
3. That a proper access to the site be effected from the factory estate road to the north-east of the site.
4. That a surface water drainage disposal, water supply and fire fighting facilities, be provided in accordance with the requirements of the Dublin County Council.
5. That the proposed boundary wall, or fence, to be erected along the Greenhills Road be set out in accordance with ~~existing~~ Plan No. C.P. 467 to allow for ~~future~~ future road improvement.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.

NOTE: An appeal against the decision may be made to the Minister by the applicant within one month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and the nature of the appellant's interest in the property affected and should be addressed to the Secretary, Department of Local Government, (Planning Appeals Section), Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.

APPROVAL OF THE COUNCIL UNDER BUILDING BYE LAWS MUST BE OBTAINED BEFORE THE DEVELOPMENT IS COMMENCED AND THE TERMS OF APPROVAL MUST BE COMPLIED WITH IN THE CARRYING OUT OF THE WORK.
