(5) That a flank screen wall not less than 6 ft in height, suitably capped and rendered, be erected at the north flank of site number 20 so as to screen the rear gardens of site number 20 and the adjoining sites from public view. (Conditions number 4 and 5 refer to visual amenity).  If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.
