Conditions:	Reasons for conditions:
(1) That the development be carried out and completed in strict conformity with the plans and specification lodged with the application, save as is in the conditions hereunder otherwise required. (2) That the following requirements of the Council's Fire Prevention Officer be adhered to in the development, i.e. (a) Means of escape to be available at all times when premises are occupied, i.e., Excise locked doors must be easily openable in emergency. (b) Adequate and suitable first-aid fire fighting equipment to be installed. (3) That the drainage arrangements, with particular regard to the disposal of surface water, be in accordance with the By-Laws of the County Council and that surface water be permitted to enter the foul sewer. (4) That Building Bye-Laws Approval shall be obtained and any conditions of such approval shall be observed in the development.
