- That the area of land coloured blue on the attached plan "o. (2)C. P. 43 be reserved for future road improvement purposes.
- That the Bond of an Insurance Company in the sum of £4,000, (3) conditioned for the provision and completion of a service road (along the Mais Road frontage and laid out in accordance with attached plan No. C. P. 429) 24 fe t wide and adjoiing footpath 6 feet wide including ancillary kerbing, surface water drain and gullies etc., for the development for which Approval may be granted pursuant to this decision, be obtained and lodged with the County Council before any development under such Approval commences. P. F. O.

If there is no appeal to the Minister for Local Government against this decision approval will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the approval as soon as may be after the withdrawal.
