In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order <u>P/812/66</u> dated <u>13th Sept., 1966</u>, make a decision pursuant to Section 26(1) of the Act to grant a permission for:

Garage and tool house at 31, Glen Auline Road, Palmerstown.

subject to the following conditions:-

- (1) That the development be carried out and completed in strict conformity with the plans and specification lodged with the application, save as is in the conditions hereunder otherwise required.
- (2) That the external finishes harmonise in colour and texture with the adjoining residential development. (This requirement refers to visual amenity).
- (3) That the proposal shall not be used for any purpose other than a purpose incidental to the enjoyment of the dwelling house as such. (This requirement refers to residential amenity).
- (4) That Building Bye-Laws approval shall be obtained and any conditions of such approval shall be observed in the development.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of . the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as such as may be after the withdrawal.

NOTE: An appeal against the Mecision may be made to the Minister by the applicant within one month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and the nature of the appellant's interest in the property affected and should be addressed to the Secretary, Department of Local Government, (Planning Appeals Section), fustom Hause, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
