I am to refer to your letter of the 8th July, 1966, and to state that before a decision on the application can be considered, the following information must be submitted:-

- (1) That plans of the front elevational view to the road of the proposed Transformer Station be submitted to the Planning Authority.
- (2) That an accurate survey map of existing trees on the site be submitted to the Planning Authority.

NOTE: The Applicant is advised to consult with an Officer of the Planning Department at 17/18, Christchurch Place, particularly in respect of the selection of trees for preservation on the site of the proposal.

In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/1652/66 dated 15th March 1967 make a decision pursuant to Section 26(1) of the Act to grant a permission for:

33 KV Station at Templeogue

subject to the following conditions:-

- (1) That the development be carried out and completed in strict conformity with the plans and specification lodged with the application.
- (2) That the necessary land be reserved for the Templeogue/Tallaght Road Improvement Scheme as indicated in blue colour on the attached C.P.452.
- (3) That the building line be in conformity with that established for this section of the Templeogue/Tallaght Road and not in advance of the adjoining dwellinghouses at the east side of the site proposed.
- (4) That Building Bye-Laws approval shall be obtained and any conditions of such approval shall be observed in the development.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.

NOTE: An appeal against the decision may be made to the Minister by the applicant within one month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and the nature of the appellant's interest in the property affected and should be addressed to the Secretary, Department of Local Government, (Planning Appeals Section), Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.

APPROVAL OF THE COUNCIL UNDER BUILDING BYE LAWS MUST BE OBTAINED BEFORE THE DEVELOPMENT IS COMMENCED AND THE TERMS OF APPROVAL MUST BE COMPLIED WITH IN THE CARRYING OUT OF THE WORK.
