In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order <u>P/752/66</u> dated <u>31st August, 1966.</u> make a decision pursuant to Section 26(1) of the Act to grant a permission for:

Restaurant at Castle Crescent, Monastery Road, Clondalkin.

subject to the following conditions:-

- (1) That the development be carried out and completed in strict conformity with the plansand specification lodged with the application, save as is in the conditions hereunder otherwise required.
- (2) That the external finishes barmonise in colour and texture with the adjoining development.
- (3) That the facia of the proposed extension be silimal in depth to and in line top and bottom with the fadia of the existing adjoining shop premises. (Conditions Nos. 2 and 3 refer to visual amenity).
- (4) That Building Bye-Laws approval shall be obtained and any conditions of such approval be observed in the development.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.

<u>NOTE</u>: An appeal against the decision may be made to the Minister by the applicant within and month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and the nature of the appellant's interest in the property affected and should be addressed to the Secretary, Department of Local Government, (Planning Appeals Section), Custem House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
