Conditions

Reasons for Conditions

(1) The development to be carried out in conformity with a grant of permission by the planning authority, the Appel requirements of the Engineering Department to be complied with prior to commencement of use of the development. Approval under the building bye-laws to be obtained and all conditions of approval to be observed in the development.	To achieve a satisfactory standard of development.
(2) Side window in proposed bedroom extension to be omitted and an adequate window to be provided instead in the rear wall of the extension; all external finishes to match those of existing house.	To safeguard the residential quality of adjoining dwellings.
(3) The entire premises to be used only as a single dwelling house and not subdivided into flats or bedsitting rooms.	To safeguard the quality of the area and prevent unauthorized development.
(4) Overall height of first floor extension to be reduced by at least 12 ins.; detailed plans showing this alteration to be submitted to and agreed by the Corporation before carrying out the development.	To safeguard residential quality.

APPEALS by Cornelius Lopergan, 32 Hillside Drive, Rathfarnham, Dublin and Kenneth Peller, 23 Hillside Drive, Rathfarnham, Dublin, against the decision made on the 13th day of December, 1973 by the Right Honourable the Lord Mayor, Aldermen and Burgesses of Dublin deciding to grant subject to conditions a permission to Terence McEvoy, 30 Hillside Drive, Rathfarnham for the erection of a kitchen, dining room and bedroom extension at Number 30 Hillside Drive, Rathfarnham, Dublin, in accordance with plans and particulars lodged with the Corporation.

DECISION: Pursuant to subsections (5) and (9) of section 26 of the Local Government (Planning and Development) Act, 1963, and after consideration of the report of the person who conducted an oral hearing of the said appeal, it is hereby decided to grant permission for the erection of the said extension, subject to the conditions specified in column 1 of the Schedule hereto, the reasons for the imposition of the said conditions being as set out in column 2 of the said Schedule and the said permission is hereby granted subject to the said conditions.

Column 1 - Conditions	Column 2 - Reasons for Conditions
1. The proposed window at first floor level in the side wall of the extension shall be relocated in the rear wall of the said extension.	1. To protect the amenity of the adjoining dwellinghouse.
2. The dwellinghouse and extension shall be used as one single dwelling unit.	2. To ensure that the development will not be out of character with existing residential development in the area which consists predominantly of houses designed for single family occupation.
3. The overall height of the extension at first floor level shall be reduced by not less than twelve inches.	3. To safeguard the residential amenity of the adjoining dwellinghouses.
