In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/341/66 dated 26th May, 1966. make a decision pursuant to Section 26(1) of the Act to grant a permission for:

Directional sign at Fox & Geese Cross, Naas Road.

subject to the following conditions:-

- (1) That the development be carried out and completed in strict conformity with the plans and specification lodged with the application.
- (2) That the directional sign be removed from the site on or before the 1st June, 1967.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.
