Bungalow at Ballinascorney Lower, Tallaght

for the following reasons:-

- (1) The proposal does not conform to the Council's density requirement in this area which is one house to 10 acres.
- (2) The drainage arrangements are not in accordance with the Council's requirements.
- (3) A Satisfactory legally binding undertaking for the purpose of sterilising the required 10 acres of land from further building in connection with this proposal has not been submitted.

In pursuance of its Functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/362/66 dated 2nd June, 1966. make a decision pursuant to Section 26(1) of the Act to grant a permission for:
Bungalow at Ballinascorney Lower, Tallaght.

subject to the following conditions:-

- (1) That the development be carried out and completed in strict conformity with the plans and specification lodged with the application.
- (2) That the proposed dwellinghouse be set back not less than 30' from the existing highway boundary.
- (3) That Building Bye-laws approval shall be obtained and any conditions of such approval shall be observed in the development.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.
