In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order TP/2882/65 dated 17/2/1966 make a decision pursuant to Section 26 (1) of the Act to grant a permission for:

Extension to House at No.63, New Road, Clondalkin

subject to the following conditions:-

- (1) That the development be carried out and completed in strict conformity with the plans and specification lodged with the application.
- (2) (That the external finishes harmonise in colour and texture with the existing buildings.
