In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order 2/10/66 dated 15/1/1966 make a decision pursuant to Section 26(1) of the Act to grant a permission for:

Housing Development at Rosemount Extension sites 1 to 15 inclusive, Ballyroan

House

subject to the following conditions:-

- (1) That the development be carried out and completed in strict conformity with the plans and specifications lodged with the application.
- (2) That the roads, sewers, water mains and other services shown on the plan or required for the development be constructed in accordance with the Co. Council's specifications for such services.
- (3) That the open space be levelled, soiled, seeded and suitably planted to the satisfaction of the Co. Council.
- (4) That building bye-laws approval shall be obtained and any conditions of such approval shall be observed in the development.

Note: Please note that this permission does not cover the complete development and that it is only in respect of the immediate proposals for 15 houses on sites 1 - 15.

If there is no appeal to the Minister for Local Government against this decision, permission will be granted by the Council on the expiration of the period for the taking of such appeal. If every appeal made in accordance with the Act has been withdrawn, the Council will grant the permission as soon as may be after the withdrawal.
