Conditions:

- (1) That the development be carried out and completed strictly in accordance with the plans and specification lodged with the application, save as is in the conditions hereunder otherwise required.
- (2) That the building be set back not less than 50-ft. from the road boundary.
- (3) That details of car parking and loading facilities be submitted to and approved by the Planning Department before any work is commenced on the site.
- (4) That Building Bye-Laws Approval shall be obtained and any conditions of such approval shall be observed in the development.
- (5) That a financial contribution in the sum of £400. be paid by the proposer to the Dublin County Council towards the cost of provision of public services in the area of the proposed development and which facilitate this development; this contribution to be paid before the commencement of development on the site.

Reasons for conditions:

- (1) To ensure that the development shall be in accordance with the permission and effective control maintained.
- (2) In the interest of proper Planning and Development of the area.
